On October 1st Johnson Memorial Health Services (JMHS) purchased the neighboring assisted living facility, Prairie Meadows. Prairie Meadows and JMHS worked together on a purchase agreement with the goal of having a smooth transition for both tenants and staff. JMHS began managing the facility in September, which helped with facilitating the transition.

In conjunction with the purchase the facility was renamed Johnson Memorial Assisted Living. With the acquisition, additional JMHS services are available to the tenants. For example, tenants are now able to attend all planned activities in the JMHS care center.

Assisted Living provides the ideal homey atmosphere for those who no longer feel comfortable living on their own, but don't need the around-the-clock medical care and supervision of a care center. We provide tenants

with the opportunity to meet new friends, begin new hobbies and enjoy a worry-free environment.

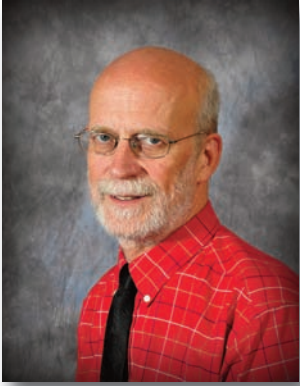

JMHS Adds New In-house Services

The results of Johnson Memorial Health Services 2012 Community Needs Assessment showed that the community was looking to JMHS to provide Oncology and Chemotherapy services. In fact 82% listed cancer as the most serious health concern in our community. We heard your concerns and made plans to address them.

Oncology and Hematology Services

In June, we brought Oncology and Hematology services to our facility on a monthly basis. Dr. Homam Alkaied, from Prairie Lakes Cancer Center, specializes in the diagnosis and treatment of patients with cancer and blood diseases. His approach to cancer care is all encompassing, treating the whole human being. He believes in collaborative and collegial teamwork to deliver the best quality of care possible to patients.



Dr. Alkaied is board certified in Medical Oncology, Hematology, Internal Medicine and Geriatric Medicine. He completed his Hematology/Oncology fellowship at Staten Island University Hospital in Staten Island, New York. Dr. Alkaied also completed his Internal Medicine residency and Geriatric Medicine fellowship at Staten Island University Hospital. He completed medical school at the Damascus University Medical School in Damascus, Syria.

In-house Mammography Services

In October, Johnson Memorial Health Services also brought mammograms in-house. Previously patients had to travel outside in the various weather elements to a truck to have their mammography examination. Services were only available twice a month which made scheduling appointments very inconvenient for patients.

JMHS was able to make space in the facility for mammography and began offering the service twice a week instead of twice a month.

Seasoned Registered Mammography Technologists Joni Gillespie and Robyn Cole are available to provide comfortable and caring exams.

Annual mammograms are so important to women's health. Up to 80% of women diagnosed with breast cancer do not have a family history of the disease. Each month JMHS will hold a drawing for \$20 in Dawson Chamber Bucks to mammography patients. We would like to thank Minnwest Bank, AGP, Strand Insurance Agency, Farmers Mutual Telephone Company, Lac qui Parle Oil Company and Breberg Agency for sponsoring the Chamber Bucks.

Chemotherapy Infusion Services

In 2009, when the new pharmacy in the hospital was built, the JMHS Board and Administration had the foresight to include space for an additional hood so that chemotherapy infusion treatments could be added to our list of services. We began to envision an Oncology Suite in 2012 when we hired our in-house pharmacist, Michelle Ross.

JMHS plans to begin offering Chemotherapy Infusion services in Spring of 2014. Before we can begin to offer these services we must purchase and install the hood for mixing the chemicals and also provide training to our staff. The nurses that will be providing the treatment will achieve an Assessment Based Certification by completing the Chemotherapy & Biotherapy course that is offered by the Oncology Nursing Society. They will also complete classes in Cancer Biology and Cancer Basics. In addition, they will get hands-on experience at Prairie Lakes Cancer Center in Watertown, SD. Our pharmacist will take an Oncology pharmacy preparatory review course and will also receive hands-on training at Prairie Lakes Cancer Center.

To help with the cost JMHS has applied for a grant from the Minnesota Department of Health and will also be doing some fundraising through the JM Foundation.

ePharmacy Services Now Being Utilized

Johnson Memorial Health Services (JMHS) is pleased to have received the Leona M. and Hary B. Helmsley Grant. JMHS was awarded \$426,973.00 to help in the purchase of equipment and supplies needed to implement ePharmacy services through Avera. ePharmacy provides rural hospitals like ours around-the-clock access to hospital-trained pharmacists making it possible for every medication order to be reviewed and approved prior to administration to patients. For our patients this means accurate medication administration, improved safety and comprehensive medication management.

Part of the funds were used to purchase two Omnicell units for the Hospital, one in the inpatient unit and one in the ER. The Omnicell units provide a secure, accurate and efficient medication management system.

ePharmacy is currently live in 42 facilities across Iowa, Minnesota, Nebraska, Wyoming and South Dakota. ePharmacy has reviewed more than 419,338 medication orders in the past 12 months and over 966,827 medication orders since inception. It has

intervened on over 26,000 medication orders resulting in over 11,500 potential serious safety events being avoided.

Since JMHS has a part time pharmacist on staff, ePharmacy is a great option for staff when the pharmacist is not in the facility.

Visit Medical Specialists Without Leaving Town

Want to see a specialist without traveling out of town? Johnson Memorial Health Services (JMHS) has two solutions for you. We have a variety of outreach specialists that visit our facility on a monthly basis. In addition eConsult allows you to access specialty services at JMHS through two-way video technology. eConsult is offered by more than 70 different providers in specialties that include infectious disease, mental health, dermatology, pediatrics, cardiology, pulmonology and oncology.

The eConsult equipment is set up in an exam room in the clinic, so eConsult visits are naturally a part of a physician's day, and mirror a typical patient-physician encounter as closely as possible. Paperwork is sent to physicians in advance of the visit so they have a chance to review the case. Just like the doctor opens the door to the exam room to see the patient, the doctor connects through the monitor. Instead of opening the

door, the doctor opens the camera.

A nurse is at the remote JMHS site to assist the specialist in assessing the patient. Through monitors at both ends, the physician can see and hear the patient; and the patient can hear and see the physician.

Johnson Memorial Health Services has partnered with Avera to provide eConsult services. Avera is a nationally recognized leader in telehealth applications that link patients, providers and specialists. In 2012, the eConsult service brought 5,700 specialty consultations to patients in rural areas across the Avera system. In addition eConsult has saved patients a total of 1,750,000 miles in travel. That is the equivalent of circling the Earth more than 71 times. About 99 percent of patients surveyed said they were highly satisfied with eConsult.
