Our focus on access and service delivery in 2023 also helped us welcome several new providers. After months of delays due to the pandemic, we were able to open our new dental office inside the Care Center. OUR PERFORMANCE

Patient Revenue increased by 7.7% in 2023, while staffing costs increased 74% due to an increase in contract staffing. At the end of 2023, Johnson Memorial Health Services had \$23.8 million invested in capital assets, net of accumulated depreciation, and \$19.5 million in outstanding debt.
